

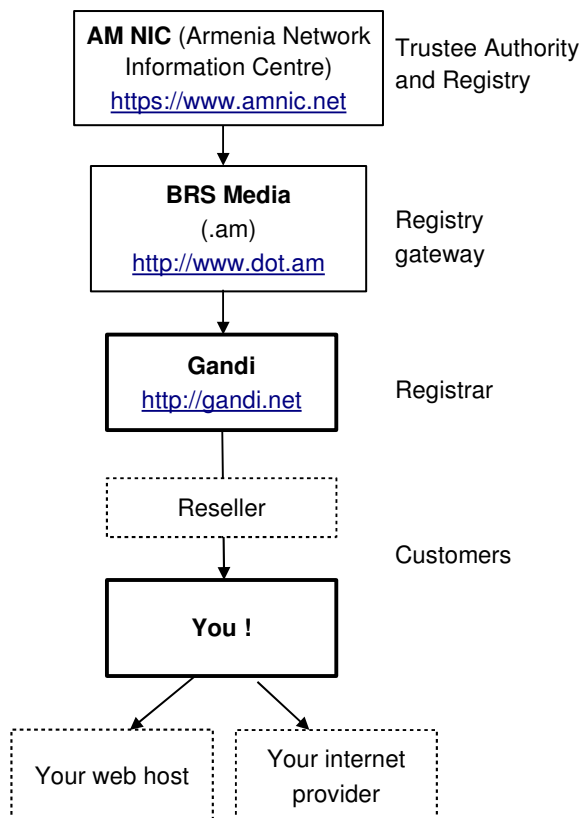

In addition to Gandi's [General Terms and Conditions](#) of domain name registration, the registration and use of a .AM domain name implies the acceptance of and compliance to the present special conditions.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in our [General Terms and Conditions](#) of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Section .AM.1. Trustee authority and Registry

.AM is the official country code Top-Level-Domain (ccTLD) of Armenia. AM domains are also used by people related to the AM Radio Station Industry. The following diagram presents the various parties involved and the Trustee Authority for the .AM ccTLD:

When You apply to register a .AM domain name, You acknowledge to have fully understood, and You agree to have full knowledge of and to abide by all the rules and specific conditions of .AM domain names, as defined by AM NIC and BRS Media, and which may be viewed at the following pages:

Section .AM.3. Special requirements

.AM domain names are open to anyone.

To register a .AM domain name, You must agree to the following conditions:

- the registration term is from 1 to 5 years,
- to avoid any deletion of the domain name, the renewal must be paid and funds cleared **no later than 2 days before the Expiration date**,
- provide and maintain accurate, reliable and up-to-date personal contact information,
- names containing two characters followed by two hyphens are not allowed.

You accept that AM NIC and BRS Media can access to Your personal data and display them in a public [Whois](#) database.

Section .AM.6. Dispute resolution policy

Section .AM.7. Transfer (change of Registrar)

There is a special procedure to handle a domain transfer. Please contact Our customer service department if You should need further information.

Section .AM.8. Ownership change

If You need to change the ownership of a domain name, please contact Our customer service department. You will have to send Us a Letter of Authorization (LOA) by which the current owner authorizes the trade to a new registrant, signed with a copy of a

identity proof of the current owner.

The owner change does not include any renewal. The creation date is reset at the Registry, and any remaining period is lost.

Section .AM.9. Deletion process

One day before the Expiration date, the domain name is released by Gandi to the Registry. All the associated technical services are deactivated.

At this time, the domain name is placed in Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department. The length of the Quarantine period is 28 calendar days.

If the domain is neither renewed nor restored within these deadlines, the Registry shall delete the domain name, which will become available for registration under the “first-come first-served” basis.
