

In addition to Gandi's <u>General Terms and Conditions</u> of domain name registration, the registration and use of a .LT domain name implies the acceptance of and compliance to the present special conditions.

All Your legal information and contracts can be viewed at any time via Our <u>website</u>. Capitalized terms have the definition attributed to them in our <u>General Terms and Conditions</u> of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at: http://www.gandi.net/admin/contracts/.

Section .LT.1. Trustee authority and Registry

.LT is the official country code Top-Level-Domain (ccTLD) of Lithuania. The following diagram presents the various parties involved and the Trustee Authority for the .LT ccTLD:



You can view the information and special rules of each party involved by clicking on the respective links.

Section .LT.2. Registration terms and conditions

When You apply to register a .LT domain name, You acknowledge to have fully understood, and You agree to have full knowledge of and to abide by all the rules and specific conditions of .LT domain names, as defined by KTU ITPI, and which may be viewed at the following page:

These contracts bind You to the .LT Registry. The present special conditions are not substitutes to these Rules, but are a part of it. You acknowledge to have fully understood and accepted these Rules on Our Website.

Section .LT.3. Special requirements

.LT domain names are open to anyone. Special requirements are available on http://www.gandi.net/domain/lt/info.

As exception to Our General Terms and Conditions of Domain Name Registration, .LT registration initial registration term is **one year minus one day**.

Section .LT.4. Storage of contact information

You accept that .LT Registry can access to Your personal data and display them in a public Whois database.

Individuals (natural persons) can opt-out of disclosing their personal information from the Registry Whois public database.

Section .LT.6. Dispute resolution policy

The Registry does not have any particular dispute resolution procedure in place concerning .LT domain names. It is up to the parties involved in the dispute to resolve the dispute between themselves, either amicably or through the courts.

Section .LT.7. Renewal

To avoid any deactivation of the domain name, the renewal must be paid and done at least one day before the Expiration date.

Section .LT.8. Change of owner

The specific ownership change (trade) rules can be viewed at: http://www.domreg.lt/public?pg=&sp=tradelt

You must log on the <u>Registry's website</u> to start and validate the process. Then the owner must, within 7 calendar days, process with the order and payment of the ownership change request, on Our website. Once the ownership change is done, You have to wait 30 days before requesting a new ownership change or a domain transfer (change of registrar).

Section .LT.9. Transfer (change of Registrar)

You must log on the <u>Registry's website</u>, and specify Gandi Sas as new registrar. Then, within 7 calendar days, You must process with the order and payment on <u>Our Interface</u>.

The transfer of a .LT domain name to Gandi does not change the domain's Expiration date.

Before requesting the transfer of the domain, please be sure that Your domain name does not expire soon (We recommend to start the transfer request at least one month before Expiration).

Section .LT.10. Deletion process

The day before the Expiration date, the domain name is

released by Gandi to the Registry. All the associated technical services are deactivated.

From this date, the domain name is placed on Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or by as communicated by Our Customer Care service. The length of the Quarantine is 30 calendar days.

If the domain is neither renewed nor restored within these deadlines, the Registry shall delete the domain name, which will become available for registration on a "first come first served" basis.
