

In addition to Gandi's <u>General Terms and Conditions</u> of domain name registration, the registration and use of a .NL domain name implies the acceptance of and compliance to the present special conditions.

All Your legal information and contracts can be viewed at any time via Our <u>website</u>. Capitalized terms have the definition attributed to them in our <u>General Terms and Conditions</u> of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. #### Section .NL.1. Trustee authority and Registry

.NL is the official country code Top-Level-Domain (ccTLD) of the Netherlands. The following diagram presents the various parties involved and the Trustee Authority for the .NL TLD:

### Section .NL.2. Registration terms and conditions

When You apply to register a .NL domain name, You acknowledge to have fully understood, and You agree to have full knowledge of and to abide by all the rules and specific conditions of .NL domain names, as defined by the Registry SIDN, and which may be viewed on:

## Section .NL.3. Special requirements

As exception to Our General Terms and Conditions of Domain Name Registration, .NL initial registration period is 12 months minus 1 day.

To apply to register for a .NL domain name, You must meet the following conditions:

- the owner and/or the Administrative Contact must provide a valid address (not P.O. box) in the Netherlands. If You do not have such local address, the Registry SIDN provides You with a domicile address, according to the <u>Domicile Address</u> Procedure.
- specify name servers (DNS) that are correctly configured for the domain name that You intend to register, according to the Registry's "zonecheck" standards,
- You must provide and maintain accurate, reliable and up-todate personal data. Invalid, false, or inaccurate information can lead to the deletion of Your domain name by SIDN,
- You must use You domain name for legal purposes. Using a domain name for unlawful and/or criminal purposes can lead SIDN to remove the domain name from the zone,
- · agree to the contracts that bind You to both Gandi and SIDN.

# Section .NL.5. Storage of contact information

You accept that .NL Registry can access to Your personal data and display them in a public <u>Whois</u> database, according to SIDN's Whois <u>Terms of use</u>.

Individuals (natural persons) can opt-out of disclosing some personal information (except Registrant name) from the Registry Whois public database, by activating Our <u>private registration</u> option, or by contacting Our Customer Care service.

The Registry may request the verification of Your contact information. In this case, You must reply within fifteen (15) calendar days, otherwise the domain will be placed on HOLD status.

## Section .NL.7. Transfer (change of registrar)

Before requesting the transfer of the domain, please be sure that You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name does not expire soon (We recommend to start the transfer request at least one month before Expiration).

The transfer to Gandi does not include any renewal. The creation date is reset at the Registry, and any remaining period is lost

Trade (changing the owner during a Registrar transfer) is not available.

## Section .NL.8. Change of owner

You must send Us a Gandi form, attached with proofs of identity.

### Section .NL.9. Deletion process

One day before the Expiration date, the domain name is released by Gandi to the Registry. All the associated technical services are deactivated.

From this date, the domain name is placed on Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or by as communicated by Our Customer Care service. The length of the Quarantine is 40 calendar days.

If the domain is neither renewed nor restored within these deadlines, the Registry shall delete the domain name, which will become available for registration on a "first come first served" basis.
